RULES & PROCEDURES

This 20th Annual Rancho Milagro USRA Fall Nationals is sanctioned by the United States Racing Association and will award Summit USRA Weekly Racing Series national, regional and track points in the USRA Modified division (no license required). Heat race passing points will determine the main event line-ups each night. The top 5 in Friday's "A" Main advance to the inside row of Sunday's "A" Main while the top 5 in Saturday's "A" Main advance to the outside row of Sunday's "A" Main.

Tire sniffer will be used, and samples will be submitted for inspection. Mufflers are mandatory (Schoenfeld #112530, #112535, #113035 or #14272735-78 only). Race cars utilizing roller cam 23-degree steel engines must weigh a minimum of 2,450 pounds and may use a five-inch spoiler.

All Modifieds must utilize a 7,800 RPM chip. All other USRA rules apply. RACEceivers and AMB transponders are required and available for rent or purchase.
